

**On Amendments and Addenda to the Resolution of the Government of
the Republic of Kazakhstan No. 336 “On Allocation of Volumes of Tariff Rate
Quotas for Imports of Certain Kinds of Meat between Participants of Foreign
Economic Activity for 2012” of 15 March 2012**

Resolution of the Government of the Republic of Kazakhstan
No. 1085 of 24 August 2012

The Government of the Republic of Kazakhstan DECREES:

1. To introduce the following amendments and addenda to the Resolution of the Government of the Republic of Kazakhstan No. 336 “On Allocation of Volumes of Tariff Rate Quotas for Imports of Certain Kinds of Meat between Participants of Foreign Economic Activity for 2012” of 15 March 2012:

Paragraph 1 shall be amended as follows:

«1. To approve the attached:

1) allocation of volumes of tariff rate quotas for imports of certain kinds of meat between participants of foreign economic activity for 2012 (Stage 1);

2) allocation of volumes of tariff rate quotas for imports of certain kinds of meat between participants of foreign economic activity for 2012 (Stage 2);

allocation of volumes of tariff rate quotas on import of certain kinds of meat between participants of foreign economic activity for 2012 (Stage 1), approved by the specified Resolution, shall be amended in accordance with Annex 1 to this Resolution;

the annex to the specified Resolution shall be added in accordance with Annex 2 to this Resolution.

2. This Resolution shall enter into force from the date of signature and is subject to official publication.
