LAW ON AMENDING AND SUPPLEMENTING ARTICLES 37, 126 AND 143 OF THE CODE OF CRIMINAL PROCEDURE

20 April 2000 No. VIII-1647 Vilnius

Article 1. Supplement to Paragraph 2 of Article 37

In paragraph 2 of Article 37, the gures and words "in Articles 142, 14242" shall be inserted after the figure and rods "in paragraph 1 of Article 131, the figure and words "in Article 308" shall be inserted after the figure and words "in paragraph 2 of Article 303" and the paragraph shall be set forth to read as follows:

"In the county court the judge alone shall heases related to crimes provided for in Articles 73, 74, paragraph 2 of Article 82, Articles 8283, paragraphs 1 and 2 of Article 85, Articles 104, 107, paragraph 2 of Article 111, apperaph 4 of Article 118, paragraph 1 of Article 1311, Articles 142, 142–1422, Articles 209, 222, Articles 22/27 (except in cases provided for in paragraph 1 of Article 37 the Code of Criminal Procedure) and 2/27 paragraph 2 of Article 23/1 paragraph 2 of Article 23/1 paragraph 3 of Article 23/2 paragraph 3 of Article 23/4 paragraph 3 of Article 23/4 Paragraph 3 of Article 23/4 Articles 23/4-23/4, paragraph 2 of Article 251, Articles 253, 254, paragraph 3 of Article 256, Article 257, 261, 264, paragraph 2 of Article 268, paragraph 3 of Article 272, pagraph 3 of Article 273, paragraph 2 of Article 282, paragraph 2 of Article 285, paragraph 2 of Article 285, paragraph 2 of Article 287, paragraph 2 of Article 289, paragraph 2 of Article 303, Article 308, paragraphs 2 and Article 312, paragraph 3 of Article 31/2 and paragraph 2 of Article 327."

Article 2. Amendment to Paragraph 5 and Repealing Paragraph 7 of Article 126

1. In paragraph 5 of Article 126, the words the Article shall be inserted after the figure "133", the words and figure "and in Articles 2" shall be deleted and set forth to read as follows:

"In exceptional cases, where the case comingrany of the crimes provided for in Article 116, in paragraphs 1 and 3 of Article 13d Article 133 of the Criminal Code of the Republic of Lithuania is of special public importate or if the plaintiff in the above cases or

the case provided for in Article 119 of the Cinian Code of the Republic of Lithuania, is unable to defend his rights and legitimate interests due to his helpless state, dependence the defendant or due to some other reasonsprosecutor shall have the right to institute the proceedings even in the absence of the pftishticomplaint. In such cases the proceedings shall be carried out according to the general procedure."

2. Paragraph 7 of Article 126 shall be repealed.

Article 3. Amendment to Paragraph 1 of Article 143

In paragraph 1 of Article 143, figures "1¹4242³" shall be inserted after the figures "134-142" and the paragraph shall be set forth to read as follows:

"In the cases concerning crimpsovided for in Articles 62-73, 7374, 74, 83, 85, 104-107, 109, 110, 118-121, 124, 129, 1382, 134-142, 142 1423, 1949, 200-2033, 209, 219-224, 229, 237, 2452454, 2439, 251-269, 298, 303, 30 and 333-344 of the Criminal Code of the Republic of Linuaria preliminary investigation shall be carried out by the investigators of the prosecutor's office."
