Appeal Provision Emergency

Where an application for a notice regarding a notified immigration decision and/or Customs and Border Protection review of a decision, the applicant can apply for a review of the decision by the Administrative Appeals Tribunal (AAT).

An applicant who is a taxpayer under protest may also apply for a review by the AAT.

An applicant notified of a decision of the AAT may appeal to the Federal Court on a question of law.
